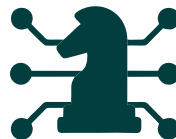

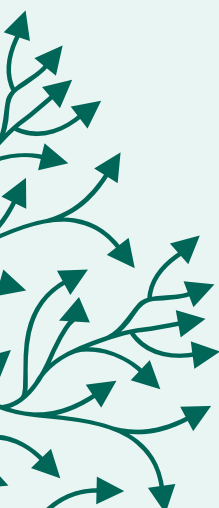

Formatting of Paper/Extended Abstract/Case Study:

- a) The full paper/extended abstract/ case study must have a short abstract of 100-200 words with three to five keywords.
- b) Papers should be written in English and submitted in word format.
- c) Figures, graphs, tables, references, and appendices should follow standard reference style.
- d) Use Times New Roman 12-point font, double-spaced, 1-inch (2.5cm) margin all around, and 8.5"x 11"-page setting.
- e) The paper should follow APA 7th edition formatting guidelines.
- f) The cover page of the paper should include the title of the paper, the name(s) of the author(s), their affiliation(s), and contact details.
- g) Papers/extended abstracts/Case study that do not follow the above instructions will NOT be reviewed.

Submission Guidelines

- a) All papers submitted for presentation at the SEEDS must contain original research that has not been previously presented or scheduled for presentation, published, or accepted for publication and if under review, must not appear in print before the Conference.
- b) Full paper should be at most 7000-8000 words (including tables, figures, notes, and references). The selected papers will be invited for presentation at the conference and will be considered for the Best Paper Award.
- c) The extended abstract of the paper should be at most 1500-3000 words (including tables, figures, and references). The extended abstract must cover the following aspects– extended abstract of the empirical paper: study hypotheses (if applicable), brief literature review, the methodology adopted, results, and implications for theory and practice.
- d) Extended abstract of conceptual or review paper must include a description of the relevant literature and some preliminary ideas for the theoretical contribution.
- e) Papers/extended abstracts that do not follow the above instructions will not be reviewed.
- f) You can locate our conference on easychair using Acronym: SEEDS 2023 Name: International Conference on Sustainability, Entrepreneurship, Equity and Digital Strategies 2023
- g) Authors must submit a full paper to be eligible for best paper awards. Only high-quality papers will be eligible for the best paper award.
- h) Certificate for co-authors will be awarded on payment of Rs 500/- per co-author, if not registered.
